Alaska FFA Star Greenhand Event

Purpose:

To recognize those outstanding FFA members in grades 8 and 9 engaged in agricultural education and motivate them to pursue excellence within the FFA. First year members who exhibit strong leadership qualities, public speaking skills, and demonstrate a well thought out plan for their Supervised Agricultural Experience (SAE) compete for the State Star Greenhand Award.

Eligibility:

Star Greenhand competitors must be an active member in good standing with the local, state, and national FFA. They must have up-to-date AET records, and be a first-year member in grades 8 or 9.

Event Rules:

- Each chapter in good standing may send two individuals to represent their chapter in the Star Greenhand Event. These individuals must be chosen at the chapter level.
- Competitors will present to a panel of 3 competent and impartial judges.
- Candidates must turn in their record book or SAE plans, and school transcript, with their chapter's State Convention registration.
- Official Dress is required for the duration of this event.

Event format:

This event has been developed to recognize and encourage first-year members to create and execute a well formed SAE plan, and grow their leadership potential, agricultural knowledge, public speaking skills, and scholarship.

The event will consist of four parts for competitors:

1. A 10 minute interview with a panel of three judges covering questions related to the student's SAE, participation in FFA, community service, and future plans.
2. An oral presentation of the FFA Creed followed by 3 questions.
3. A 25 question written test that may cover topics relating to leadership, plant science, animal science, mechanics, or general FFA knowledge.
4. Submission of Complete Record Book Report from AET, and a school transcript to be reviewed and judged by the panel of judges, focused on the scope of the project, goals, clarity of information, planned SAE activities, and student academics. Records must be submitted with the chapter's State Convention registration.

The student will complete their interview with the panel, followed by their presentation of the creed.

Records submitted past the registration due date will be docked 20 points, 20% of the total possible points for records.

Scoring/Judging:

All records provided by the competitor will be viewed and scored by the panel of interviewing judges prior to the event.

During the creed portion of the event, the student will be judged and scored by the same judges as those competing in the Creed Speaking LDE.

All three portions of the event will total into the cumulative score for each member.
